Ejecución del proyecto

Comentario: Se han descrito y evidenciado las tareas ejecutadas en el transcurso de este proyecto. La comunicación entre los socios y la planificación de las actividades realizadas hasta el momento ha sido correcta. Las actividades previstas para el tiempo restante resultan realistas y se adecuan a los objetivos planteados en el proyecto. No obstante, se evidencia un retraso de encuentros transnacionales, con nueva fecha de celebración prevista para Enero-Junio 2021. Se recomienda subsanar la celebración de encuentros demorados para garantizar el cumplimiento de los objetivos del proyecto y para la publicación y difusión de los resultados.

Gestión del proyecto

Comentario: La cooperación y el reparto de tareas entre los socios resulta adecuada. Relativo a las partidas de gasto de GESTIÓN Y EJECUCIÓN DEL PROYECTO: asciende a 36.000,00 eur. Esta partida se considera adecuada y se justifica por su dedicación a gastos entre los que se incluyen fundamentalmente gastos relacionados con actividades incluidas en los encuentros internacionales, gastos relacionados con la planificación y ejecución del proyecto, generación de material educativo y también hosting y dominio de la página web del proyecto y su mantenimiento y actualización (www.erasmusvet.eu). Relativo a la resolución de problemas: En el interim report se detallan una serie de dificultades. Algunas de las dificultades han podido ser subsanadas. No obstante, se han producido desajustes en los cronogramas y en la programación de reuniones que es necesario reprogramar. Entre las dificultades que se han encontrado se encuentran las dificultades asociadas a la situación de pandemia y otras de diversa índole como son la participación de algunos coordinadores con experiencia previa en este tipo de convocatoria, que se ha podido compensar mediante formación específica. Así mismo, se han puesto de manifiesto algunos retrasos que afectan a la planificación y correcta ejecución del proyecto, como son: - <u>Retraso del tercer encuentro en Turquía, inicialmente programada para Abril de 2020 y por realizar. - Retraso del cuarto encuentro en Rumanía, inicialmente programado para Octubre de 2020 y por realizar. - Retraso de encuentros transnacionales, modificados previsiblemente para Enero-Junio 2021 y por realizar. Se requiere subsanar la celebración de encuentros que han sido demorados para garantizar el cumplimiento de los objetivos del proyecto y su contribución a los resultados del mismo.</u>

Otra información relevante

Comentario: Relativo a la sostenibilidad de los resultados el proyecto se indica que, los centros participantes se comprometen a mantener y difundir los resultados a los centros que lo demanden. Además, se manifiesta que los centros educativos participantes se comprometen a mantener los materiales y herramientas trabajadas durante el desarrollo del proyecto en sus respectivas webs de centro. Sin embargo, el mantenimiento web construida ad-hoc para este proyecto finalizará tras el desarrollo del proyecto. La explicación aportada limita el uso, difusión y la sostenibilidad de los resultados. Únicamente se contempla una difusión pasiva (a la espera de que otros centros la demanden a alungo de los socios). Sería preferible incluir medidas de difusión activa, al menos en centros próximos o relacionados con los centros de formación participantes. Por otra parte, se indica que se dedicarán recursos a mantener la información en las web de cada centro una vez finalizado el proyecto. Sin embargo, el mantenimiento de la web creada para el proyecto finalizar al finalizar el proyecto. No tiene demasiado sentido multiplicar y fragmentar la información en la web de cada centro. Es preferible dedicar recursos al mantenimiento de dominio y actualización de contenidos de la web del proyecto en su conjunto (www.erasmusvet.eu), no cesar su mantenimiento a la finalización del proyecto, tal como se manifiesta.


